HMA Presents Two President's Award

The "President's Award" was introduced when ElGene Ver Dught was HMA president. It is presented to individuals who are not practitioners but who have significantly contributed to the understanding and utilization of conflict resolution in our communities. Past recipients have included media celebrities and public officials who have effectively given conflict resolution a priority, and successfully established resources that bring conflict resolution into everyday lives.

The presentations were made during the banquet at the Regional Conference on April 1.

This year, we were pleased to present this award to two worthy recipients. The first recipient was **PETER KINDER**, Lt. Governor of the great state of Missouri.

Lt. Governor Kinder began his advocacy for conflict resolution as a state senator by writing a number of new sections for Chapter 452



of the Missouri statutes, regarding the use of mediation in domestic relations cases. As these sections became law, conflict resolution became an important component for the settling of disputes concerning the dissolution of marriage and its impact on children.

During his last three legislative sections as senator, he sponsored Senate Bill 1081 which would require mediation in home construction and remodeling disputes. These disputes - after divorce - represent one of the most common forms of dispute individuals bring to the courts. This bill would establish conciliation and mediation as required steps before the ligation and adjudication of a case, thereby potentially reducing the burden on the parties to resolve these matters.

Lt. Gov. Kinder's advocacy and leadership for conflict resolution has helped to firmly establish the use of mediation in Missouri statutes, thereby fostering the greater use of these methods throughout the state.

The President's Award was also presented this year to the HONOR-ABLE JAMES BEASLEY, who is classified as an "active retired" judge by the Kansas Supreme Court.

During the 15 years Judge Beasley served as Presiding Judge of the Family Law Department of the 18th Judicial District in Wichita, he

advocated for the development of mediation and other conflict resolution resources in his district and the state of Kansas.



At the state level he was joined by Judge Herbert Walton of Olathe and Judge James Buchele of Topeka as leaders in the promotion of conflict resolution in domestic relations cases in the state of Kansas.

He brought input from resources around the country through his long affiliation with the Association of Family and Conciliatory Courts, where he has been a consistent presence and resource.

Working with local professionals in the therapy field such as Jeanne Erikson, he developed a comprehensive ADR policy for the family law court of Sedgwick County. From this grew a range of services to families including case management, which eventually resulted in legislation defining this resource for Kansas courts.

Judge Beasley also advocated for the successful development of divorce resources for children, including the "Children of Divorce Workshop" for parents — one of the first in the

Peer Mediation Awards

arly each year the Heart land Mediators Association seeks nominations from Kansas and Missouri schools to receive the organization's Peer Mediation Awards. The nominees may be schools in grades Kindergarten through grade 12 that have active peer mediation programs.

Heartland is interested in identifying schools that have implemented peer mediation as a means of resolving conflicts between its students. More fundamentally we are interested in schools providing a practical educational mediation experience for their students. These programs provide hands on opportunities for student mediators and students in conflict as well as others in the student body to experience or learn of the benefits of alternative dispute resolution. Heartland Mediators Association is also interested in helping schools establish and maintain mediation programs.

This year one of the winning schools was nominated by a peer mediator and the other school was nominated by a sponsoring faculty member. The winners were an-

nounced at the Annual Banquet on April 1, 2005. They are:

NORTH-EAST MIDDLE SCHOOL FROM KANSAS CITY, MISSOURI and the

COUNCIL GROVE, KAN-SAS MIDDLE SCHOOL FROM COUNCIL GROVE, KANSAS.

The nomination of Northeast Middle School was made by student mediator Sabrina Lees. The faculty sponsors were Iris Porter and Bill Bing. In her nominating statement Sabrina Lees said their school has had a peer mediation program for 10 years. The program includes from 15 to 25 students in grades 6, 7, and 8. Their experience has shown that the peer mediation program helps build self esteem, confidence, leadership skills and helping skills. They find that their mediation services helps resolve problems, develop trust, build friendships, and provides positive role models for others. More specifically peer mediation helps prevent fights and suspension of those involved. According to Sabrina Lees the program also helps relieve peer pressure.

Trainers for Northeast Middle School have included Dr. Russ Thompson from University of Missouri, Kansas City; Michael Patterson, a student mediator from Southeast High School; and members of the Young Lawyers Association. This year the mediation team was trained by Elicia

Redmond from the Kansas City Human Relations Department, who began her mediation career while in high school.

The nomination from the Council Grove Middle School was submitted by faculty sponsor Rodney Hollis. In his letter of nomination Mr. Hollis told us the Council Grove Middle School has operated a peer mediation program for 12 years. In that time the peer mediators have helped resolve student conflicts in over 415 cases with no clients repeating. The sponsor's initial training was provided by Dr. Joan Belamy from Hutchinson, Kansas High School. The student training is provided by the sponsor, Mr. Hollis. It includes training in listening skills, responding skills, and mediation role play. The Council Grove student mediators are trusted students chosen.

individually by the student body and therefore are very representative of the student population. The student mediators must meet the same standards as student athletes to retain their eligibility.

Referral to the Council Grove Middle School mediation program may be made by other students, teachers, teacher aids, administrators or mediators. The school counselor coordinates the timing and the location for the mediation. All sessions are conducted as co-mediations with only the students present and follows a prescribed printed format. Each student, the counselor and the administrator receives a copy of the mediated agreement. The mediators are offered a debriefing after the mediation is completed.
