FORENSIC INTERVIEWING

October 20, 2006 in Wichita

YOU HAVEN'T HAD A CHANCE TO ATTEND TRAINING LIKE THIS, PROBABLY EVER

Retired Kansas Bureau of Investigation Special Agent, Kelly Robbins to present

What is it that mediators do more than anything else? If you said ,"ask questions and listen to answers," you are right on. But, who taught you to ask questions and how do you know that you're asking the right ones to enable you to get the truth; maybe more important is knowing what to not ask, whether it is a child or an adult.

Heartland's October 20, 2006 meeting in Wichita will feature training presented by Kelly Robbins, a well experienced forensic investigator.

This training will be of great value to all mediators as we learn how the most careful of investigators go about their delicate task.

The protocols and interviewing skills used will be of value in every type of mediation and will have other life applications for you.

Kelly Robbins retired in 2005 after twenty years service with the Kansas Bureau of Investigation. Her last seven years were as a Special Agent investigating child abuse cases in western Kansas.

Kelly is the past president and the current Executive Director of Finding Words of Kansas. Finding Words is a leading nationally recognized effort to train forensic investigators in the RATAC protocol. This is a widely-recognized protocol for interviewing

children believed to be victims of child abuse. The Finding Words training also prepares the learner to prepare the child for court appearances.

Kelly will also acquaint us with the multi-disciplinary team approach to dealing with the dynamics involved with these cases. These are dynamics we should learn to recognize as mediators and mandated reporters.

Kelly will discuss mandated reporting legal requirements and give us tips on our role if child abuse is discovered or suspected.

The emphasis in questioning is to get the truth through an "interview," as opposed to interrogation.

Come join us.

Learn the difference and get started on building some greater skills.

Ten Years of Restorative Justice

Respect, a restorative justice program supported by the Clay County Juvenile Office and Juvenile Court (Missouri), is beginning its 10th year of operation.

The program uses direct dialogue between the crime victims and juvenile offenders, facilitated by mediators, to provide opportunities to understand the harm caused by the offense and discuss arrangements for making things right.

Youthful offenders must take responsibility for their participation in the offense as a pre-requisite to entering the program.

Although offenders are held accountable for their conduct, special care is taken to support and respect all people involved.

Crime victims choose to voluntarily participate in directly getting answers to their questions about the offense and determining appropriate reparations.

The program is especially useful in resolving neighborhood disputes and interpersonal conflict constructively.

The focus on restoring all those impacted by the offense as functioning members of the community has an impact beyond the "trail 'em nail 'em, jail 'em" goals of traditional criminal justice.

The rate of recidivism for youth who participate in the program is Very low. Less than 10 percent of offenders referred to the program will have another referral to the Juvenile Office within a year.

The rate is just one percent for youth who engage in face-to-face meetings.

An average of 60 to 70 cases were mediated each year and face to-face meetings resulted in apology and/or reparation arrangements in 93 percent of cases this year.

Community service agreements and payment arrangements for restitution were completed in about 90 percent of these cases.

The Community Mediation Center in Independence provided screening and mediation services for the Respect program. At various times funding for the program has been provided in part by The Conciliation Center, Missouri Department of Public Safety and the Missouri Division of Youth Services. Participants receive services free of charge.

K-State Now Has Conflict Resolution Certificate Program

At K-State you can now earn a graduate or undergraduate certificate in conflict resolution. This program is ideal for people who may be getting or already have a bachelor's or master's degree, and would benefit from academic study of conflict analysis and resolution so they can apply their knowledge in their current field or profession.

Conflict resolution skills are skills that everyone needs in their repertoire in order to address the complexity of individual and collective lives. Used effectively, these particular skills can promote individuals' capacities and responsibilities for making decisions about their lives, build a sense of community, foster mutual respect and cooperation, and develop the use of fairness rather than power as a basis for resolving disputes.

On a personal level, those who learn how to effectively manage/resolve conflicts are able to manage different demands, personalities, and behaviors, while setting a positive example to others. When conflicts do occur, they are able to intervene early, prevent disputes from escalating, resolve them comprehensively, and repair broken relationships.

The certificate program requires four, three-credit-hour courses, for a total of 12 credits. The courses are offered by K-State's School of Family Studies and Human Services in the College of Human Ecology, and are facilitated by K-State's Division of Continuing Education.
